THIS AGREEMENT made and entered into by and between;

WHEREAS, the Entity is desirous that certain works must be executed and completed for the **CONTRACT OF SERVICE FOR THE ACCOMMODATION, VENUE WITH MEALS AND SNACKS FOR THE CONDUCT OF BFP REGION 1 SEMESTRAL COMMAND CONFERENCE, CY 2021;**


WHEREAS, the contractor has accepted the works/services in the sum of **ONE HUNDRED EIGHTY-SEVEN THOUSAND, SIX HUNDRED PESOS (Php 187,600.00)**, hereinafter called "the Contract Price";

WHEREAS, the Contractor shall undertake the project for **Two (02) Calendar Days on the scheduled date of the activity** in accordance with the plans, specifications, delivery/completion period indicated in the attached *proposal* submitted by the contractor which was hereby made as an integral part of this contract;

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - (a) Request for Quotation
 - (b) Abstract of Quotation
 - (c) Technical Specifications (if applicable);
 - (d) Notice of Award;
 - (e) Performance Security (if applicable); and
 - (f) Notice to Proceed.
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods/services and to remedy defects

therein in conformity in all respects with the provisions of the Contract.


4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.


5. WHEREAS, advance payment not to exceed fifty (50%) percent of the contract amount shall be allowed for contracts entered into by the entity for the following services;

- a. Hotel & Restaurant Services;
- b. Use of Conference/Seminar and Exhibit Areas; and
- c. Lease of Office Space

6. WHEREAS, failure of the Supplier to effect the project in accordance with Para four (4) hereof without any fault on the part of the Entity shall be sufficient grounds for the cancellation/termination of this contract.
